Since this time, the program PCC has continued to evaluate the restructured program by using student feedback, the CVMA tasklist, IAC feedback, VTNE scores, and practicum placement site feedback. Animal Nutrition and Terminology (AHT 1080) is the proposed course to replace the multi-semester course Discover Your Dream (AHT 1120). AHT 1080 will prioritize key GACs preparing our students for success in the workplace. With the proposed deletion of Discover Your Dream (AHT 1120) the course name for Stream Your Dream: Perform (AHT 2110) no longer aligns with the program and we are proposing that the name change to Clinical Skills to reflect the content of the course.
