 - 3.1. Werklund School of Agriculture Technology
 - 3.1.1. Revised Course Outline and Competency Profile ATG 2001 Agricultural Equipment Design and Function (J.Benkie)
 - To reflect the precision agriculture concept in the course description to be aligned better with the name of the Diploma Program "Precision Agriculture Techgronomy".
 - Context Initially ATG 2001 was approved at Academic Council in November 2020 based on subject matter expert course development work. Since this approval, the instructor who will

be teaching this course has been revising the content and also working on course development for the Bachelor of Digital Agriculture Degree. The instructor has worked to improve the content of ATG 2001 to provide students with the most accurate, and relevant course experience. This course will be taught in the fall of 2021 in the Precision Agriculture Techgronomy Diploma and this course will also be included in the program of study for the Bachelor of Digital Agriculture to be offered in fall of 2022. It was important to have this course reviewed and approved by the Academic Council in September.

- J. Benkie confirmed that this does not change the intent of the course. He also confirmed that this course has not yet been taught this academic year. This course has been reviewed by the Ag Tech team through formal processes.
- Discussion around the importance of reviewing the current guidelines in procedures D34 and D21 to determine if any changes are necessary to timelines
