- 3. NEW BUSINESS POLICY APPROVAL
 - 3.1. <u>D27 Granting of Credit Briefing Note</u> / <u>Policy</u> / <u>Track Changes</u> (D.Bullock)

- The majority of the revisions were in the wording to accommodate greater flexibility in program delivery including accelerated programming and programming that does not follow a traditional 15-week semester schedule.
- Friendly amendment: Add relevant policies to the "Related Information" section, including D21 Course Development and Review, D22 Program Review, D24 Academic Scheduling, D34 Program Development, and potentially others. Dalin will look into whether D20 Graduation and Convocation should be included as well.
- Friendly amendment: Under "Hours of Instruction", add "30 credit" so that the sentence now reads as "..., each 30 credit program of study at Olds College will include at least 450 contact hours..."
