## Job Shadowing/Employment Requirement – 40 Hours



**Please provide this information to your employer/clinic/supervisor before or while completing your hours to gain the most value from your experience!**

Applicants to the Olds College Veterinary Technology (VT) accelerated diploma program are required to complete a minimum of **40 hours** of job shadowing and/or employment in a single Canadian veterinary clinic. The required hours may also be completed in a Canadian SPCA, Humane Society, Animal Shelter or Wildlife Rehabilitation Centre provided it is affiliated with a licensed veterinarian or practice.\*.

\*These alternate facilities will only be considered eligible if a licenced veterinarian is regularly present and they are involved in the direct care of the animals in the facility. The facility must have an established veterinary, client, patient relationship with a licensed veterinarian. **Applicants should contact the Office of the Registrar to receive prior approval, if considering an alternate location other than an established veterinarian clinic.**

The completion of these hours and submission of the Verification Form is a requirement for applicants to be considered for the program. These hours are required so the applicant is able to gain an understanding of the veterinary industry by experiencing day to day activities and while also being able to interact with veterinary professionals. The veterinary industry is both rewarding and challenging! Applicants to the VT program should use this opportunity to generate an awareness of expectations, tasks, and responsibilities of AHT's and other veterinary staff.

In order to help the applicant, become aware of the expectations, tasks, and responsibilities of VT's, we are providing you with a list of areas and duties we hope you are able to expose the applicant to. These areas and duties are a recommendation only, location dependant and are not a requirement.

- Basic handling and restraint of animals
- Husbandry and nursing care of animals
- Different species and breeds of animals
- Clinic safety protocols
- Diagnostic laboratory procedures
- Reception duties
- Euthanasia
- Surgical preparation

### Small Animal

- Spay/Neuter
- Dentistry
- Vaccination
- X-rays

### Large Animal

- Nursing and Treatment Procedures
- Surgery
- Equine Dentistry

- The job shadowing and/or employment hours must be completed prior to being offered admission.
- Hours must be completed within the last two years prior to making application.
- If you have, or would like to complete job shadowing and/or employment hours outside of Canada, please contact the Office of the Registrar/Students Services for prior approval.
- This form must be signed by the Veterinarian, RVT, or person who most closely supervised the applicant in the location where the job shadowing and/or employment hours were gained. Forms signed by family or friends will not be accepted.
