Alumni Association Committees

As part of the Alumni Association Strategic Plan, several committees have been formed to accomplish our goals. These include the following committees:

By-Laws, Constitution, and Strategic Planning Committee (MOU)

Goals – To have relevant & updated Mission & Vision Statements, review the Board Structure and Committees required.

Logistics - To review the by-laws and constitution on a regular basis to ensure they are relevant to the Alumni Association; to ensure that they are available to all alumni, to ensure they meet the needs of the Alumni Association. Review previous strategic plans and brainstorm future goals.

Fundraising and Sponsorship Committee

Goals – To invite business, organizations and individuals to support the Alumni Association. To complete and submit necessary applications to AGLC licensing for events to benefit the association visually and financially.

Logistics – Develop sponsorship packages appropriate to the event and the potential sponsor. Research AGLC conditions for eligibility and application documentation requirements, submission of paperwork and follow-up.

Halls of Fame/ Merit Selection & Director Nomination Committee

Goals – To ensure the criteria for the Hall of Fame is appropriate and relevant, source a list of volunteer candidates for Board elections.

Logistics – Review the criteria, advertise for applicants, create a selection committee, and follow guidelines in the Hall of Fame Handbook. Have regular meetings to review the criteria for board nominations, contact potential candidates about elections, confirm the availability of potential candidates, and coordinate the election process. Source previous Hall of Fame/Merit nominees.

Summer Reunion Committee

Goals – to host a summer reunion with high attendance.

Logistics –plan, implement and host all summer reunion activities including: registration, meals, decorations, tours, etc. (may require sub-committees)

Museum Committee

Goals –develop a long term strategy and plan for the museum

Logistics - liaise with Olds College to develop and implement a plan of action.
